## An important update for Y11 students and parents from Mr Yates:

We appreciate that many of you have been working hard, since the school closed, to complete work set on Google Classroom to support your GCSE studies. This work will have been invaluable in furthering your understanding of your curriculum areas, and it is testimony to you as individuals that it has been approached by so many with such maturity and focus. We thank you for your efforts so far.

Ofqual has now released detailed information about how they'll be calculating grades this summer for GCSEs. It is important that parents and students take time to read through the <u>letter</u> below as it will answer many of the questions you will have had. We absolutely have to follow this <u>quidance</u> and this will lead to us refining our approach to ensure no student is disadvantaged as a result of the current situation.

- Ofqual guidance for teachers, students, parents and carers regarding Summer 2020 grades.

Firstly, teachers will be asked to produce a grade which in their professional judgement we would expect you to achieve had everything been 'normal at school'.

We will need to consider what you would have gained had you been in a position to complete your GCSE studies normally and been able to take advantage of all of the support and interventions that would have been offered. Within this we will obviously be able to reflect improvements in attitude and effort demonstrated in Year 11 by so many of you.

Secondly, and to achieve absolute fairness, we are no longer allowed to set Year 11 students' work to do in their GCSE subjects, and then use this to inform their GCSE grades.

As I am sure you appreciate, many students across the country are simply not in a position to complete such work and so it would be unfair to use work in such a way. Curriculum work on Google Classroom will therefore no longer be set, however your teachers are still available should you have any questions or concerns or want support in the next steps of your education. We may, therefore, still set some work on Google Classroom to support future study at college and information on this will follow where necessary. Grades will not be submitted any earlier than  $29^{th}$  May, and this provides time for the process to be done carefully and with due diligence.

The centre assessment grades submitted to exam boards must reflect a fair, reasonable and carefully considered judgement of the most likely grade a student would have achieved if they had sat their exams this summer and completed any non-exam assessments (NEA). No student will be disadvantaged if they have not completed all of their NEA, the grade submitted will reflect the grade the student would have achieved had they had the time to complete the NEA.

The exam boards will look carefully at the grades submitted to ensure there is fairness and consistency between all schools

Schools must not, under any circumstances, share these grades with students, or their parents/carers before the final results have been issued. Since the final grades for some or all students in a centre could be different from those submitted, it also helps to manage students' expectations. Once centre assessment grades have been submitted to exam boards, the process to produce the final grades will start. More information will be made available to centres, students, parents and carers at the time final results are issued, to facilitate any appeals against the process.

#### Year 11 Leavers' Hoodies


